## **Overview**

AidData's Financing the 2030 Agenda for Sustainable Development Dataset Version 1.0 provides aggregated data on Official Development Assistance (ODA) and Other Official Flow (OOF) commitments to the 17 Sustainable Development Goals (SDGs). This release builds on the previous iteration of the SDG coding methodology released in November 2017 (*Estimating Baseline Aid to the Sustainable Development Goals*). This release uses novel machine learning tools to automate this methodology and expand coverage through 2021.

AidData's Autocoding Finance for Sustainable Development methodology is based on an analysis of ODA project descriptions and involves four steps: (1) a mapping between first-level activities and SDG targets; (2) training a text-classification tool leveraging three text-classification models on a dataset where this mapping has been hand-coded, then processing new data with this tool; (3) splitting an aid project across designated activities; and (4) splitting the dollar value of an aid project across the associated goals (for further detail, see *Autocoding Finance to the Sustainable Development Goals Methodology, forthcoming, AidData*). These steps allow us to estimate the total aid at the goal level for each of the SDGs.

The dataset was developed by AidData with the generous support of the William and Flora Hewlett Foundation.

A forthcoming version 1.1 data release will also include the full, unaggregated project-level data. However, as this dataset contains over 3.2 million project entries, we believe that a release of partially aggregated data will be most useful to the general research audience.

## **Data Sources and Brief Methodological Notes**

This dataset uses project-level data on ODA, OOF, Private Development Finance, and Equity Investment (2000-2021) reported to the OECD Creditor Reporting System (CRS).

AidData's prior *Estimating Baseline Aid* approach drew upon OECD CRS data, and assigned SDG codes to a project based on the activities identified in the project title and descriptions. This approach provided a granular level of detail, and captured the SDG elements of multi-sector projects more comprehensively than previous efforts. However, this method relied on a large team of student researchers and multiple stages of review and consolidation. For reference, 36 different student researchers coded 104 thousand projects over two years of that methodology's implementation. With these labor requirements, any SDG-coded data would be at least three years out of date by the time it was reviewed and ready for publication.

Nevertheless, the dataset that the students compiled, once complete, proved to be an invaluable training dataset for modern machine learning algorithms. Distinguishing across the 2030 Agenda's 169 targets introduces a high degree of complexity, and machine learning algorithms required tens of thousands of sample projects to properly model this complexity (for further detail, see *Autocoding Finance to the Sustainable Development Goals Methodology, forthcoming, AidData*). With an internal database of hundreds of thousands of projects coded by trained researchers, and more advanced text classifiers open to the public in 2022, AidData's team were finally able to upgrade our process and toolkit. With the new machine-learning tools, we have the ability to overcome prior delays and produce updated SDG data and analysis within a few months of development data publication, not within a few years.

This methodology is based on automated analysis of development project descriptions and titles. Where activity descriptions were insufficient to assign an SDG code, the v1.0 coder relied on OECD CRS purpose codes, which were not as granular as activity descriptions, and generate estimates based on a naïve diffuse assumption about what activities were involved in a project with a given purpose code.

The methodology involves three main steps:

1. Mapping first-level activities to SDG targets;
2. Training a text-classification tool leveraging three text-classification models on a dataset where this mapping has been hand-coded, then processing new data with this tool;
3. Splitting an aid project across designated activities; and
4. Splitting activity amounts across SDG targets, as a purpose code may be linked to multiple targets. For further detail, see *Autocoding Finance to the Sustainable Development Goals Methodology, forthcoming, AidData*.

While we recognize that components of an aid project may receive differing levels of resources in practice, the available project documentation seldom contains this level of granularity on how money is distributed at the sub-project level. Therefore, we split dollar values equitably across the naïve diffuse assumption of activities included in each purpose code, the best available option in the absence of perfect information. Having split the dollar value of a project across unique activities, we distribute those activity-dollar amounts evenly across the SDGs goals associated with the “parent” purpose code.
